

EIR Request (received 26 September 2022) - Reference: DFI/2022-0314

Can you confirm how many Parking Tickets (PCN's) were issued in Magazine Street, Londonderry, for each month in October, November and December 2021.

Can you confirm how many Parking Tickets (PCN's) for each day in October 2021 were issued in Magazine Street, Londonderry?

Can you confirm how many Residents parking permits were in place for October 2021?

Can you confirm if Magazine Street was used as a filming location in October, November or December 2021?

If so, was vehicular access required? Were any permits required or issued?

Response (issued 21 October 2022)

I refer to your email received on 26 September 2022 requesting information under the Freedom of Information Act relating to Penalty Charge Notices (PCNs) issued at Magazine Street, Londonderry, and details of Resident Parking Permits.

In considering your request on behalf of the Department, I have determined that the information requested falls under the aegis of the Environmental Information Regulations 2004, as opposed to the FOI Act 2000.

For ease of reference, I have numbered your queries, in the order asked, and respond as follows:

1. The table below shows the number of PCNs issued at Magazine Street, Londonderry for October, November, and December 2021.

2. The table below shows dates during October 2021 when PCNs were issued and the totals for each day.

3. There are seven parking permits issued annually to the residents of Magazine Street.
4. Magazine Street (from the junction of Union Hall Place with Shipquay Street to the junction of Magazine Street with Butcher Street) was used as a film location on the following two dates:
 - 9 November 2021 from 18:00 until 00:30; and
 - 12 November 2021 from 09:30 until 16:00
5. A full Road Closure Order was issued for the filming in November 2021, this removed the requirement for permits to be issued.
